Overview

Amadeus IDPMS release version 4.1.5 contains new functionality making it possible to preconfigure new VAT percentages in case of a change in VAT. We also added the possibility to configure specific items in a charge plan with a start- and/or end date.

Furthermore, it contains a new integration with the Shift4EMV payment and tokenization provider.

It also contains additional enhancements and bug fixes.

Update schedule

Amadeus IDPMS version 4.1.5 will be delivered to your hotel through the IDPMS Onpremise Update Module (OPU). For hotels running IDPMS v3.16.4 or higher, the deployment is announced via the IDPMS e-mail module for selected users.

The time between announcement and actual update may vary per hotel, as the deployment will be done in smaller batches of hotels.



! Note:

- Hotels that have the On-premise Update (OPU) Setting <u>not set to "Full Install"</u> are NOT updated automatically.
- Multi property environments or hotels that have IDPMS running on a terminal server environment are also NOT updated automatically.

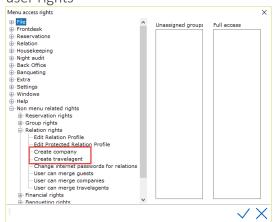

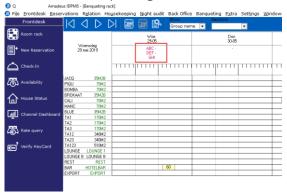

Bugfixes and features in initial release

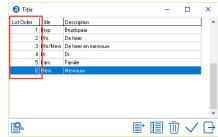
24185: Creating companies and travelagents can now be restricted by user group through user rights



24234: The banqueting rack will now show 3 lines of event calendar data



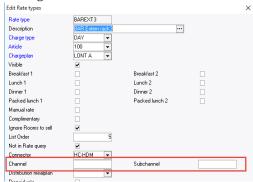
- 24243: The field for PIN-code was obsolete and has been removed from the different relation windows
- 24253: Titles in IDPMS now have a configurable sort order



24265: A pop-up is now generated when moving a reservation that is part of a group to the waitinglist from within the group reservation



- 24291: The column for "State" will no longer be visible in the company and agent browse screens when the option to use states is not enable
- 24332: A check will now be done if the configured invoice documents folder exists on the server. If not, it will be created
- _ 33034: The fields for Channel and Subchannel have been removed from the rate type configuration form



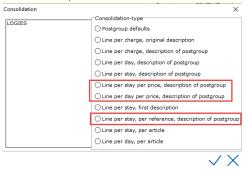
- _ 33818: Optional functions LATEFEE and LATEFEES have been removed from the chargeplan configuration as these were obsolete
- _ 34138: Columns for Phone and Phone 2 have been added to the browse screen when searching for a guest profile to add to a reservation. These fields can be searched on as well



36184: Changed the label for CRO into Ext. Ref in the reservation window



- _ 37762: When translating a new room type description, IDPMS no longer produces the error "List Index out of bounds"
- 37898: Improved several consolidation descriptions in the change consolidation screen



- 38592: All manual rebuilds started from IDPMS will now be logged in the database
- _ 40249: The group field in "settings advanced hotel reports" has been changed into a dropdown-box that can be filled from a picklist that can be configured in "settings – picklists – Hotel Report Groups"



41186: The standard PLU in "settings – financial – payment types" is no longer limited to articles with a number lower than 99 and will show all payment articles



 43746: Added a field for Extra Group to the Extra Type configuration (settings – financial – extra type)



- 43777: Parameter 2 field has been removed from Autorun Procedures configuration as it had no function
- 43811: In case the room number in a reservation has not been assigned yet, the "do not move" checkbox can no longer be used and will be greyed out



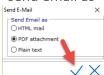
- 43829: The option "settings advanced system traces" has been removed from the menu as it did not have a function
- 44145: IDPMS now has an option to view the Configuration Changes Log where changes in configuration are stored. A more detailed explanation can be found here

- 45013: Improved the description labels for email body templates in "settings advanced invoice layout"



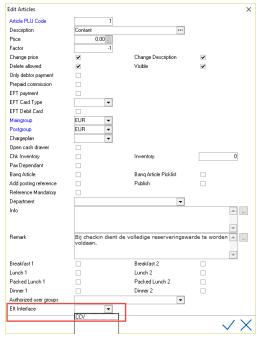
- _ 53462: Forecast data will now be stored in separate tables in the database, so it can be retained for reporting purposes (like pickup reporting).

- 59827: It is no longer possible to change the number of rooms for a reservation that has been created online and contains an external reference



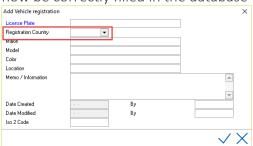
_ 60629: The default focus when entering the "send email window" has been changed from "send email as" to "confirm" enabling users to simply press enter to continue



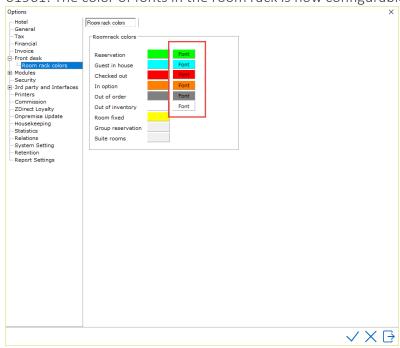

_ 60918: The ISO2 code for the selected country in the Vehicle Registration module will now be correctly filled in the database



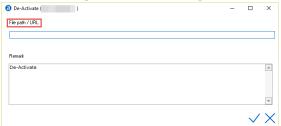

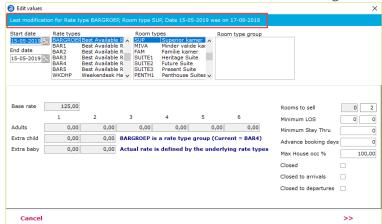
_ 64526: When creating a debtor invoice, users will now be presented with the option to print, email or do nothing



63536: Changed a label in the guest forms concerning GDPR

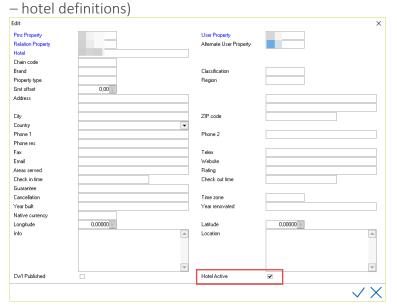

- 69029: Added date of last modification to the rate grid edit form

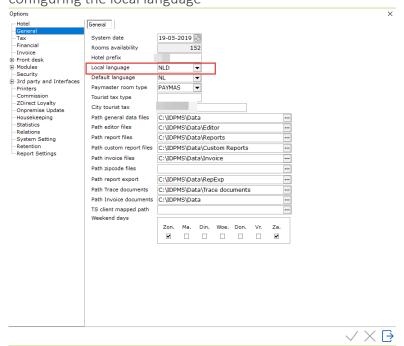

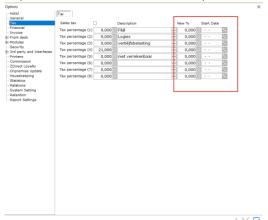

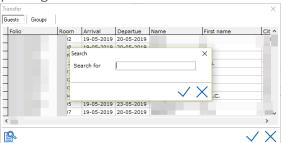
_ 70405: IDPMS will now only show the correct available language options when configuring the local language



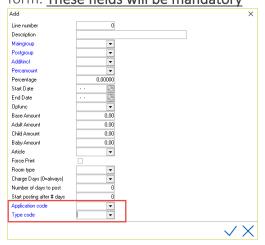

- 73291: It is now possible to search on a specific folio number when manually transferring postings

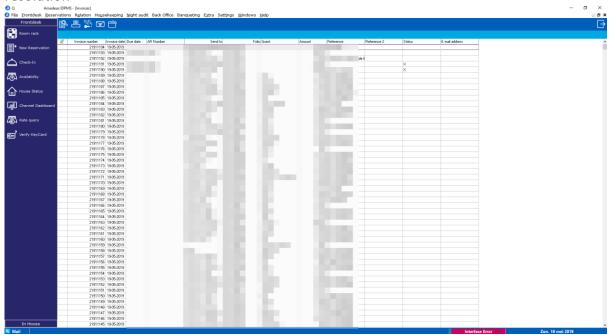

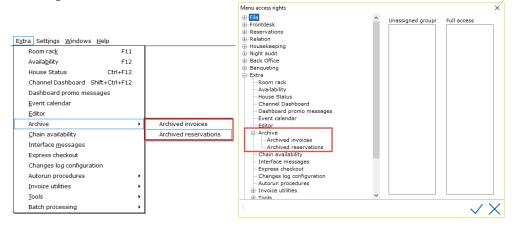
75431: It is now possible to delete multiple Out of Order or Out of Inventory records by multi-selecting them using the Ctrl-Key and clicking on the waste bin icon



_ 75646: Added a field for country ID to the guest profile to enable storing the country the guest's ID card was issued in



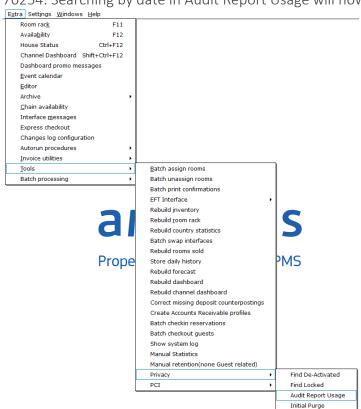

_ 75976: Created a new menu item "Frontdesk – Check Out" (shortcut is Ctrl+K). Choosing this menu item will lead to pending checkouts for the selected date (default is the current IDPMS date). The menu item for "Frontdesk – Checked Out" (shortcut is Ctrl+U) has been renamed to "Departed". Choosing this item will lead to reservations that have already departed

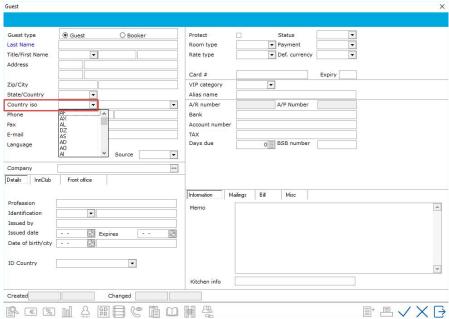

- _ 83766: The confirmation name field can no longer be changed in IDPMS after storing the confirmation configuration in the database

- 84972: Changed shortcut Shift+F10 to Ctrl+Shift+F10 for report selection



- _ 85590: Changed label "Exclude from rate Manager" in company profile to "Exclude from Rate Plan Optimization" in order to make it uniform with the option it refers to

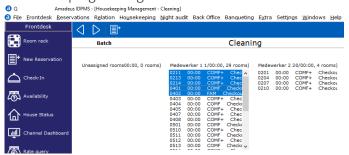
- 89447: Improved handling of incorrect start and end times for (master) activities and (master) calculations in the banqueting module

- _ 89976: The SMTP password will now be stored and shown encrypted. Double clicking on the field will show the unencrypted password



90221: Email addresses in the SMTP configuration having a length longer than 30 characters are now correctly stored in the database

- 91859: It is now possible to select multiple rooms using shift or Ctrl in step 3 of the Housekeeping Management Module



92776: Added new configuration options for POS interfaces to IDPMS menu

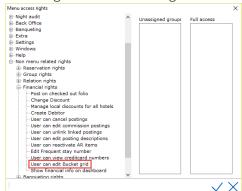

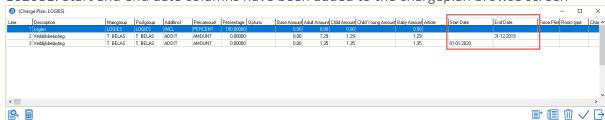


- 95747: Made it possible to do a multi-select when preparing a batch to Accounts Payable in the Owner Accounting module

96123: Added data for state/province to the COUNTRY dropdown in the Vehicle Registration module and changed the label accordingly. The dropdown will show states first, then countries in alphabetical order. This functionality will only work when the hotel has enabled the use of states in the IDPMS options



- 96353: In the Owner Accounting module it is now possible to navigate to the next/previous record using PgUp/PdDn
- 96357: Label "Trust Accounting" changed to "Owner accounting"
- 96358: Menu item "Bank reconciliation" is removed from the Owner Accounting module as it was not functional

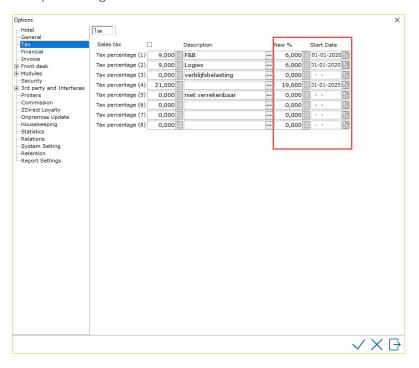
Bugfixes after initial release

- ___ Multiple improvements were made to how the Shift4EMV payment provider works
- 113592: Fixed incorrect masking of CC numbers when (transaction)tokens are present
- 113796: Fixed an issue where IDPMS would crash on a specific query if OLEDB was used as database connection method
- _ 113902: Checked out reservations can now always be stored (also when for example the memotext has been changed).
- _ 114331: Values for 'Rate type group' and 'Derived from' can no longer be the same. If this is the case, the reservation cannot be stored. This will prevent errors when creating a reservation.
- __ 114693: Shift4: of settlement on credit card is declined, void request is properly sent to Shift4
- _ 115006: Rolled back changes to the rate type dropdown in (group)reservation so it no longer uses the same logic as in Rate Query screen. This in response to user feedback on the (now rolled back) functionality.
- __ 115248: Created new logic in Shift4 for use of card type DB (Debit)

Setting up new VAT percentages

In Amadeus IDPMS version 4.1.5 it is possible to setup new VAT percentages in advance in case of a future VAT change. To do this, please go to "settings – options - Tax".

In the column "New %" the new VAT percentage needs to be filled for those VAT groups that will need to be changed. The start date can be filled with the intended start date for the new VAT percentage.



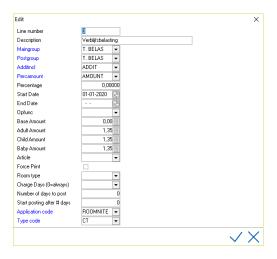
When these values are filled, pro forma invoices and forecast data will make use of the new percentages for calculations falling after the start date that was entered in the start date column.

During the night audit where the IDPMS system date reaches the filled out start date, the values from the "New %" column will be moved to the column containing the original percentages and the values in the "New %" and Start Date columns will be deleted.

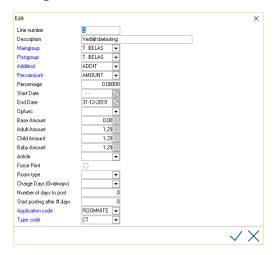
Start and end date in chargeplans

Chargeplans now contain functionality to enable adding of a start and/or end date to individual lines in the chargeplan configuration. This should eliminate the need for creating separate chargeplans in case a change will occur for a line in the chargeplan on a future date (e.g. a change in the price of a breakfast component or tourist tax).

Filling the start date will cause the line in the chargeplan to be calculated starting on that date



Filling the end date will cause the line in the chargeplan to be calculated until that date



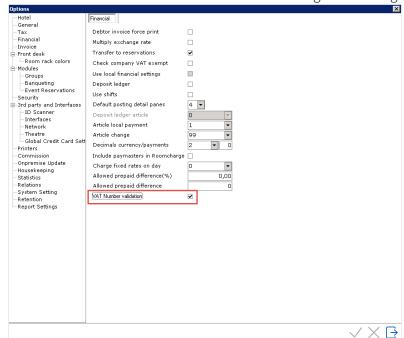
A combination of start and end date is also possible. Please note that IDPMS will stop charging the chargeplan line after the end date, unless the end date is removed or changed to a later date.

VAT Number Validation

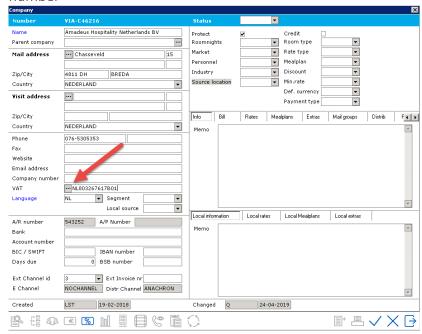
IDPMS now contains the possibility to check VAT numbers using the VAT Information Exchange System (VIES) of the EU. More information can be found here.

In IDPMS this works as follows.

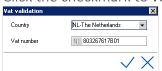
First activate the "VAT number validation setting" in "Settings – options - financial"



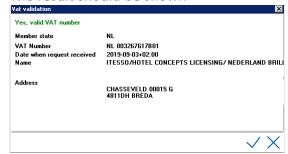
In the company or travelagent profile window there is now an option to validate the VAT number



In the window that pops up country and VAT number (without prefix) should be filled. Click the checkmark to verify



The result should be shown



Shift4EMV

Shift4EMV is a secure payment processing and tokenisation solution. Amadeus IDPMS version 4.1.5 contains a certified integration with this provider, making it possible to send payment requests directly from IDPMS to the Shift4 EMV terminals, perform authorisations and receive and process the responses for these requests in real time, processing them directly into IDPMS.

The tokenisation option will send credit card data captured in IDPMS directly to Shift4. A token (which is a reference to the card number as stored in the Shift4 database) will be returned and stored in the IDPMS database. This eliminates the need for storing sensitive credit card data in the IDPMS database, greatly reducing the PCI DSS scope for the hotel.

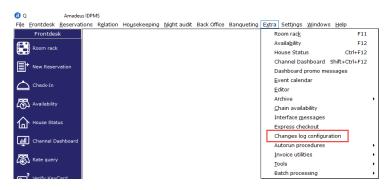

Configuration Changes Log

The configuration changes log is where changes in the IDPMS configuration are stored (e.g. changes in different settings). IDPMS now has an option to look at that changes log.

The option can be found under "Extra" in the IDPMS menu tree:





After retrieving the data, different filters can be applied, and the data can be scrolled through.

Data Archiving

Functionality has been added to IDPMS that makes it possible to archive old data. This data will be moved from the production tables in the database to designated archive tables. Performance should improve by doing this by reducing the amount of data in the tables that IDPMS actively uses. This data will remain accessible from the IDPMS menu, the associated menu items can be found under "Extra - Archive".

Archiving of data will have to be started manually from the IDPMS menu and cannot be automated. Prerequisites are:

- Fully completed GDPR purge must have been performed
- __ Credit Card purge must have been executed during each night audit

If the above conditions are not met, it will not be possible to (completely) archive your data.
